BY THE BLESSING OF THE ALMIGHTY GOD

THE REGENT OF BANJARNEGARA,

Considering : that to implement the provisions of Article 5 of Government Regulation Number 77 of 2007 concerning Regional Emblems, it is necessary to establish a Regional Regulation concerning the Regional Emblem;

Observing :
1. Article 18, Paragraph (6) of the 1945 Constitution of the Republic of Indonesia;
2. Law Number 13 of 1950 concerning the Formation of Regencies within the Province of Central Java (State Gazette of the Republic of Indonesia Year 1950 Number 42);
3. Law Number 23 of 2014 concerning Regional Government (State Gazette of the Republic of Indonesia Year 2014 Number 244, Supplement to the State Gazette of the Republic of Indonesia Number 5587), as amended several times, most recently by Law Number 11 of 2020 concerning Job Creation (State Gazette of the Republic of Indonesia Year 2020 Number 245, Supplement to the State Gazette of the Republic of Indonesia Number 6573);
4. Government Regulation Number 77 of 2007 concerning Regional Emblems (State Gazette of the Republic of Indonesia Year 2007 Number 161, Supplement to the State Gazette of the Republic of Indonesia Number 4790);

With the Joint Approval of
THE HOUSE OF REPRESENTATIVES OF BANJARNEGARA REGENCY
And
THE REGENT OF BANJARNEGARA

HAS DECIDED:

To enact : REGIONAL REGULATION CONCERNING THE REGIONAL
EMBLEM.

CHAPTER I
GENERAL PROVISIONS

Article 1

In this Regional Regulation, the terms shall be defined as follows:

1. Region refers to Banjarnegara Regency.
2. Regent refers to the Regent of Banjarnegara.
3. Regional Government refers to the Regent as the executive element of the Regional Government, who leads the implementation of government affairs that are within the authority of the autonomous region.
4. The House of Representatives is the regional representative institution that acts as an element of the Regional Government.
5. Regional Government is the administration of government affairs by the Regional Government and the House of Representatives based on the principle of autonomy and co-administration, with the broadest possible autonomy in the system and principles of the Unitary State of the Republic of Indonesia as referred to in the 1945 Constitution of the Republic of Indonesia.
6. The Regional Emblem is the banner of honor and cultural symbol for the regional community that reflects the distinctiveness of the region within the Unitary State of the Republic of Indonesia.
7. Regional Apparatus refers to the supporting elements of the Regent and the DPRD in the administration of government affairs that are within the authority of the region.

Article 2

The scope of this Regional Regulation includes:

- a. The regional emblem;
- b. The design of the regional emblem; and
- c. The use and placement of the regional emblem;

CHAPTER II
REGIONAL EMBLEM

Article 3

The Regional Emblem includes:

- a. The regional logo;
- b. The regional flag;

- c. The official flag of the Regent; and
- d. The regional hymn and march.

Article 4

- (1) The Regional Emblem serves as an identity marker for the region.
- (2) The Regional Emblem functions as a unifying symbol of the social and cultural cohesion of the regional community within the Unitary State of the Republic of Indonesia.

CHAPTER III DESIGN OF THE REGIONAL EMBLEM

Part One Regional Logo

Article 5

- (1) The design of the Regional Logo as referred to in Article 3, point a, is in the shape of a green shield with a gold-yellow border, depicting 14 (fourteen) elements of nature or structures arranged artistically, consisting of:
 - a. an upright pentagon symbolizing the character, personality, and spirit of unity and solidarity of the Banjarnegara community, based on Pancasila;
 - b. a stalk of rice with 17 (seventeen) golden grains on the right side of the pentagon, symbolizing the Independence Day of the Republic of Indonesia;
 - c. a cluster of 8 (eight) fully opened white cotton bolls on the left side of the pentagon, symbolizing the month of Indonesia's independence;
 - d. rice and cotton represent a bright future for the people of Banjarnegara in building a prosperous society blessed by The Almighty God.
 - e. a yellow-golden five-pointed star, symbolizing strong religious faith;
 - f. red and white colored fields within the pentagon signify the Region as an inseparable part of the Unitary State of the Republic of Indonesia;
 - g. a banyan tree with green leaves symbolizes the Region as a shelter for a peaceful and prosperous life, with four hanging roots representing the elements of earth, water, air, and fire, symbolizing the harmony between the people of Banjarnegara and their natural surroundings;
 - h. Arjuna Temple represents the high cultural values and greatness of the Banjarnegara community;
 - i. a black *keris* without ornamentation, symbolizing the heroic spirit and loyalty of the Banjarnegara people to the values of truth and honesty;

- j. Panglima Besar General Soedirman Dam symbolizes great creativity that brings benefits to the well-being of the Banjarnegara community and its surroundings;
 - k. river water with 3 wave lines represents the Serayu River that flows throughout the Region and is used for agriculture, fisheries, and industry;
 - l. rice fields and potato plantation plots symbolize the diverse natural resources in the Region, serving as a source of livelihood and sustenance for the people;
 - m. green, fertile land represents the rich, prosperous soil of the Region, along with its clean and cool air;
 - n. The row of light blue mountains symbolizes that the Region is surrounded by mountain ranges to the north and south, the North Serayu Mountains and Dieng Plateau in the north, and the South Serayu Mountains in the south; and
 - o. A yellow-gold sash below the pentagon, bearing the name "BANJARNEGARA" in black lettering.
- (2) Below the shield as mentioned in paragraph (1), there is a white ribbon inscribed with the motto "Manunggaling Swara Tumataning Praja" written in black capital letters, which represents the historical date of the Region's establishment in 1571 AD, signifying the unity of the people and the Regional Government in building and organizing life towards the realization of a "Baladatun Thayyibatun wa Rabbun Ghafur," a region blessed with prosperity and happiness both materially and spiritually for all Banjarnegara residents.
- (3) The design of the Regional Logo as referred to in paragraphs (1) and (2) is detailed in Annex I, which is an integral part of this Regional Regulation.

Part Two Regional Flag

Article 6

- (1) The design of the Regional Flag as referred to in Article 3, point b, is rectangular with a length-to-width ratio of 3:2, featuring the regional logo.
- (2) The Regional Flag has a green background with white and black borders and black lettering.
- (3) The depiction of the Regional Flag as referred to in paragraphs (1) and (2) is detailed in Annex II, which is an integral part of this Regional Regulation.

Part Three
Official Flag of the Regent

Article 7

- (1) The design of the Official Flag of the Regent as referred to in Article 3, point c, is rectangular, measuring 30 centimeters in length and 20 centimeters in width, with the national emblem depicted in the center on a blue background.
- (2) The national emblem on the Official Flag of the Regent is silver-coloured with a silver border.
- (3) The depiction of the Official Flag of the Regent as referred to in paragraphs (1) and (2) is detailed in Annex III, which is an integral part of this Regional Regulation.

Part Four
Regional Hymn and March

Article 8

The notation and lyrics of the Regional Hymn and March as referred to in Article 3, point d, are detailed in Annex IV, which is an integral part of this Regional Regulation.

CHAPTER IV
USE AND PLACEMENT OF THE REGIONAL EMBLEM

Part One
Regional Logo

Article 9

- (1) The Regional Logo as referred to in Article 3, point a, may be used on:
 - a. Official Regional Government/Village Government buildings;
 - b. Gates;
 - c. Boundary markers between regencies;
 - d. Official letterhead of Regional Government/Regional Apparatus;
 - e. Stamps of Regional Apparatus;
 - f. Badges or images; and
 - g. Official uniforms and other clothing.
- (2) The Regional Logo as mentioned in paragraph (1) shall not be used for:
 - a. Official meetings of the Regent with foreign partners/bodies/institutions; and
 - b. Agreement documents to be signed by the Regent with foreign partners/bodies/institutions.

Article 10

- (1) The Regional Logo used on official buildings as mentioned in Article 9, paragraph (1), point a, may be placed on the exterior or interior of the building.
- (2) The placement of the Regional Logo on the exterior of the building as referred to in paragraph (1) may be done on name boards:
 - a. regent's office;
 - b. the House of Representatives office;
 - c. regional Apparatus offices;
 - d. sub-district offices;
 - e. village offices;
 - f. official residences of the Regent and Deputy Regent;
 - g. official residence of the House of Representatives Chairperson;
 - h. official residence of the Regional Secretary; and
 - i. school buildings/educational facilities owned by the Regional Government.
- (3) The placement of the Regional Logo on the interior of the building as mentioned in paragraph (1) is done in:
 - a. offices of the Regent and Deputy Regent;
 - b. office of the House of Representatives Chairperson;
 - c. the House of Representatives meeting room;
 - d. the offices of Regional Apparatus Heads;
 - e. sub-district offices;
 - f. village offices;
 - g. reception areas in the official residences of the Regent and Deputy Regent; and
 - h. the offices of school principals/heads of educational institutions, teachers' rooms, administration offices, classrooms, meeting halls/auditoriums, and reception areas in school buildings/educational facilities owned by the Regional Government.
- (4) The placement of the Regional Logo on the exterior or interior of buildings as mentioned in paragraphs (2) and (3) should not be higher or at the same level as the placement of the national emblem.

Article 11

- (1) The Regional Logo, apart from being placed as mentioned in Article 10, may be placed together with the logos of other institutions/commercial enterprises in open/closed spaces
- (2) The placement of other institutions'/commercial enterprises' logos as referred to in paragraph (1) should not be higher than the position of the regional logo.

Article 12

- (1) The Regional Logo used on gates and boundary markers between regencies as mentioned in Article 9, paragraph (1), points b and c, shall comply with the prevailing laws and regulations.
- (2) The Regional Logo used on the letterheads of Regional Apparatus and stamps of Regional Apparatus as referred to in Article 9, paragraph (1), points d and e, shall follow the official document guidelines in accordance with the prevailing laws and regulations.
- (3) The Regional Logo used as a badge or image and/or as part of other clothing as mentioned in Article 9, paragraph (1), points g and h, shall be placed on the upper left chest, collar, or cap.
- (4) The Regional Logo used on official uniforms as mentioned in Article 9, paragraph (1), point g, shall follow the official uniform guidelines in accordance with the prevailing laws and regulations.
- (5) The placement of the Regional Logo as referred to in paragraph (5) should not be higher or at the same level as the placement of the national emblem badge or image.

Article 13

The Regional Logo used as a badge, as referred to in Article 9, paragraph (1), point f, which is worn by members of the House of Representatives, may include the abbreviation "DPRD" and the rice and cotton symbol.

Part Two Regional Flag

Article 14

- (1) The Regional Flag, as referred to in Article 3, point b, may be used alongside the national flag at:
 - a. official buildings of the Regional Government/Village Government;
 - b. gates;
 - c. borders between regencies; and
 - d. badges or images and/or as part of clothing.
- (2) The size of the Regional Flag used alongside the national flag, as referred to in paragraph (1), must not be equal to or larger than the national flag.
- (3) The Regional Flag may be used and displayed in official meetings between the Regent and foreign partners/bodies/institutions.
- (4) The use and placement of the Regional Flag in official meetings, as referred to in paragraph (3), should be done alongside the national flag.

Article 15

- (1) The Regional Flag used on official buildings as referred to in Article 14, paragraph (1), point a, may be placed on the exterior/interior of the building.
- (2) The placement of the Regional Flag on the exterior of the building, as mentioned in paragraph (1), may be done at:
 - a. the Regent's office; and
 - b. the official residence of the Regent and Deputy Regent.
- (3) The placement of the Regional Flag on the exterior of the building, as mentioned in paragraph (2), should not be higher or at the same level as the national flag.
- (4) The placement of the Regional Flag on the interior of the building, as referred to in paragraph (1), is done in:
 - a. the reception and working rooms of the Regent and Deputy Regent;
 - b. the main meeting room at the Regent's office;
 - c. the office of the House of Representative Leaders and the House of Representative meeting room;
 - d. the reception area in the official residence of the Regent and Deputy Regent;
 - e. the reception area in the official residence of the House of Representative Chairperson;
 - f. the office of the Sub-district Head;
 - g. the office of the Village Head; and
 - h. the office of the School Principal/Head of Educational Institutions in school buildings/educational facilities owned by the Regional Government.
- (5) The placement of the Regional Flag inside the building, as referred to in paragraph (4), should not be higher or at the same level as the national flag.
- (6) When the Regional Flag is placed alongside the national flag, the regional flag should be positioned on the right.

Article 16

The Regional Flag, as referred to in Article 3, point b, shall not be flown during national day ceremonies in the region, regional anniversary ceremonies, or other flag-raising ceremonies.

Article 17

The Regional Flag used on gates and boundary markers between regencies, as referred to in Article 13, paragraph (1), points b and c, should be placed higher than the flags or streamers of commercial enterprises.

Article 18

- (1) The Regional Flag used as a badge or image/part of clothing, as referred to in Article 14, paragraph (1), point d, should be placed on the upper left chest, collar, or cap.
- (2) The placement of the Regional Flag, as mentioned in paragraph (1), should not be higher or at the same level as the badge of the national emblem.

Part Three Regent's Office Flag

Article 19

- (1) The Regent's Office Flag, as referred to in Article 3, point c, is used only during national day ceremonies in the region and regional anniversary ceremonies.
- (2) The Regent's Office Flag, as referred to in paragraph (1), is placed on the official/residential vehicle of the Regent in the center, outside the front.

Part Four Regional Anthem and March

Article 20

- (1) The Regional Hymn and March, as referred to in Article 3, point d, may be played after the national anthem, Indonesia Raya, at national day ceremonies in the region and regional anniversary ceremonies.
- (2) The Regional Hymn and March, as mentioned in paragraph (1), shall not be played at official meetings between the Regent and partners/bodies/institutions from abroad.

CHAPTER V CLOSING PROVISIONS

Article 21

Upon the enactment of this Regional Regulation, the following are repealed and declared void:

- a. the Regional Regulation of Level II Region of Banjarnegara dated January 21, 1969, concerning the Regional Emblem, as amended by the Regional Regulation of Banjarnegara Number 11 of 1988 regarding the First Amendment to the Regional Regulation of Level II Banjarnegara concerning the Regional Emblem; and

- b. the Regional Regulation of Level II Region of Banjarnegara dated January 27, 1969, concerning the installation and use of the Banjarnegara Regional Emblem.

Article 22

This Regional Regulation shall come into force on the date of promulgation.

To ensure that everyone is informed, the promulgation of this Regional Regulation is ordered by its placement in the Official Gazette of Banjarnegara Regency.

THE REGIONAL EMBLEM

I. GENERAL

In administering regional autonomy, the regional government has obligations, including protecting the community, maintaining unity and national harmony, and preserving the nation's social values within the Unitary State of the Republic of Indonesia. The preservation of the social and cultural values of the regional community is reflected, among other things, in the Regional Emblem as a regional identity. As a regional identity, the regional emblem depicts the region's potential, the hopes of the regional community, and the motto that illustrates the spirit to realize those hopes.

The cultural values embedded in the Banjarnegara community are an extraordinary strength and need to be utilized properly. The nation's cultural assets, which are of immeasurable value, must be preserved and developed. This is crucial not only for maintaining cultural diversity but also for ensuring the continued existence and development of traditional values.

The hopes of the Banjarnegara community, which are realized through various regional government policies, essentially represent the crystallization of the community's aspirations. The existence of an emblem is a unifying identity as well as a shared hope. Thus, the regional emblem holds a very significant position in regional governance, and therefore, the regulation of the regional emblem by the regional government is outlined in a regional regulation.

The legal basis underpinning the regional emblem policy has been established, both in the 1945 Constitution and Government Regulation Number 77 of 2007 concerning Regional Emblems. However, along with developments regarding the change of the Anniversary Day of Banjarnegara Regency, adjustments to the regional emblem need to be regulated in a regional regulation.
